

Privacy policy

KG takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website. **Please read this privacy policy carefully.**

Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to Uwe Müller Baumaschinen GmbH & Co. KG via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Act 1998;
Uwe Müller Baumaschinen GmbH & Co. KG, we or us	Uwe Müller Baumaschinen GmbH & Co. KG, a company incorporated in England and Wales with registered number ----- whose registered office is at Dürerer Str. 589a, Eschweiler, 52249;
User or you	any third party that accesses the Website and is not either (i) employed by Uwe Müller Baumaschinen GmbH & Co. KG and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Uwe Müller Baumaschinen GmbH & Co. KG and accessing the Website in connection with the provision of such services; and
Website	the website that you are currently using, https://www.baumaschinen-mueller.de , and any sub-domains of this site unless expressly excluded by their own terms and conditions.

2. In this privacy policy, unless the context requires a different interpretation:

- a. the singular includes the plural and vice versa;
- b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

3. This privacy policy applies only to the actions of Uwe Müller Baumaschinen GmbH & Co. KG and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

Data collected

4. We may collect the following Data, which includes personal Data, from you:

Our use of Data

5. For purposes of the Data Protection Act 1998, Uwe Müller Baumaschinen GmbH & Co. KG is the "data controller".
6. We will retain any Data you submit for 1 month.
7. Unless we are obliged or permitted by law to do so, and subject to any third party disclosures specifically set out in this policy, your Data will not be disclosed to third parties. This includes our affiliates and / or other companies within our group.
8. All personal Data is stored securely in accordance with the principles of the Data Protection Act 1998. For more details on security see the clause below (Security).
9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
 - a. internal record keeping;in each case, in accordance with this privacy policy.

Third party websites and services

10. Uwe Müller Baumaschinen GmbH & Co. KG may, from time to time, employ the services of other parties for dealing with certain processes necessary for the operation of the Website. The providers of such services do not have access to certain personal Data provided by Users of this Website.
